## SERVICE AWARDS POLICY

(as approved and adopted by the Management Committee 20/07/2023)

When considering the application of Clause 3 of the Swanbourne Nedlands SLSC By-Laws (as reproduced below):

- 1. For members in the "Active", "Award" or "Cadet" membership category, the term "service" requires that a minimum of 16 patrol hours be performed within a given season.
  - 1.1. For members in the "Associate" membership category, the term "service" requires that a minimum of 16 Service hours be performed within a given season.
    - 1.1.1. Service hours may be acquired by Associate members filling the role of an Officer of the Club or those completing other significant duties as determined by the Management Committee within a given season.
    - 1.1.2. Associate Members meeting the criteria outlined in 1.1.1 will be identified by the relevant Club Manager at the start of each season, to ensure their hours can be accurately recorded.
    - 1.1.3. As non-patrolling members, Associate members meeting the above criteria are eligible for Club Service Awards but not Long Service Membership.
- 2. Where a member has previously received the 5-year service award, these criteria will only apply to years subsequent to the year in which the award was obtained.
- 3. In recognition of the commitment required to obtain the award which qualifies that member to perform patrols; The season in which the award was obtained shall be recognised as one year of service, regardless of the amount of patrol hours performed by the member in that season.



# SWANBOURNE NEDLANDS SURF LIFE SAVING CLUB

This policy is not intended to undermine or replace the discretion of the Management Committee when considering the application of Clause 3 of the Swanbourne Nedlands SLSC By-Laws.

It is intended to provide a greater degree of transparency and certainty for members whilst recognising the Club's primary object is to "carry out the work of surf life-saving".

#### 3. Service Awards

### 3.1 Long Service Award

- 3.1.1 Members who have given 10 years of service to the club will be presented with a suitably inscribed badge to the design illustrated in Appendix 2 of this Constitution
- 3.1.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis.

### 3.2 5 Year Service Award

- 3.2.1 Members who have given 5 years of service to the club will be presented with a suitably inscribed badge to the design illustrated in Appendix 3 of this Constitution
- 3.2.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis.
