## **HISTORY**

#### **Five Year Service Awards**

Like the Long Service Award. the Five Year Service Award is only given to those who have given service to the Swanbourne Nedlands SLSC. Introduced in 2002, it was given to any member who had given five or more years service to the Club. Accordingly. some individuals received their 5 and 10 Year Awards very close together, eg. Anna Lee received hers a single year apart.

At the 8<sup>th</sup> June 1986 Annual General Meeting the Constitution was amended to add a membership category for Long Service Membership.

#### Long Service Membership

Long Service Membership may be granted by the Club to members who have completed ten (10) active years active service or to members who have completed eight (8) years service plus four (4) years reserve active service.

Minor changes were made during changes to the Constitution when the Club operational structure was updated in July 1997. That Long Service members have voting rights was added and Association was changed to SLSWA and SLSA.

At the 23<sup>rd</sup> July 2000 Annual General Meeting the Constitution was amended to allow for the Club Award:

Resolution 2: To add to the category of Long Service Membership so that in addition to the State membership, a member can earn a club award for 10 years service specifically to the Club.

That the following amendments be made in order to effect Resolution 2:

The deletion of clause 6.6.4 and replacement with the following:

"6.6.4 Long Service Members who have completed ten (10) active years active service at Swanbourne Nedlands SLSC or to members who have completed eight (8) years service plus four (4) years Active Reserve at Swanbourne Nedlands SLSC shall be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 3 of this Constitution.."

Resolution 3: To add to the category of Long Service Membership so that a member can earn a club awards for 5 years service specifically to the Club.

That the following amendments be made in order to effect Resolution 3:

The deletion of clause 6.6.5 and 6.6.6 and their replacement with the following:

"6.6.5 Long Service Members who have completed five (5) active years active service at Swanbourne Nedlands SLSC shall be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 4 of this Constitution.."

"6.6.6 The Life Membership Committee will monitor awards and make recommendations to the Management Committee on the presentation of this award."

At the 14<sup>th</sup> July 2002 Annual General Meeting the Constitution was amended to differentiate between the membership category and the Club award.

Resolution 2: To differentiate between the Long Service Award awarded by the Swanbourne Nedlands SLSC and the Long Service Membership category of the Surf Life Saving Association (for both the 10 year and 5 year service awards)

That the following amendments be made in order to affect Resolution 2:

The deletion of clauses 6.6.1, 6.6.4, 6.6.5, 6.6.6 and their replacement with the following:

"6.6.1 Long Service Membership must be given by the club to members who have completed ten (10) years Active Service or to members who have completed eight (8) years Active Service plus four (4) years Active Reserve service."

- 3.2. 5 Year Service Award
- 3.2.1 Members who have given 5 years of service to the club will be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 2 of this Constitution.
- 3.1.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis."

### **BY-LAWS**

#### 3.2 5 Year Service Award

- 3.2.1 Members who have given 5 years of service to the club will be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 3 of this Constitution.
- 3.1.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis.
