ENGRAVING

The year of award is engraved on the front of the badge. The recipient's name is engraved on the rear of the badge.

HISTORY

Long Service Awards

Long Service membership is a membership category that any surf Club affiliated through SLSA is obliged to offer. It includes any member who has been an Active member for ten or more seasons, or who has been an Active for eight seasons and then an Active Reserve for four seasons. A member may have Long Service membership at Swanbourne without having given ten years of service to the Club if some or all of that service was done at another Club.



In addition to, and completely separate from, this, Swanbourne has a Long Service Award. This is a medallion that is presented to any member who has given ten or more year's service to the Club. It does not apply to patrolling members only and members may gain this award for service in administration, education, fund raising, coaching or other facets of Club life. Unlike Long Service membership, it is only awarded to those who have given ten years service to the Swanbourne Nedlands Surf Life Saving Club.

The list below is a list of all the ten Year Service Award members and does not include Long Service members unless they have given ten years service at Swanny.

Membership Definitions

The 1979/80 season will be remembered as a period of far reaching legislation which had a profound effect upon the Association.

It was the season of the implementation of the National Annual Proficiency Test programme and also it was the season to pave the way for the introduction of female life savers.

No less important in its own right, was the action of the National Council in adopting National definitions for Association membership.

In reflection, it was truly amazing the subject had not been nationally addressed at some previous period of our 73 year history.

The need of common definitions did not become evident till a National survey was carried out into the (Club) categories of membership, patrols, equipmentand the results tabulated.

Intolerable variations were found to exist between Clubs, especially in admittance to the membership category of "active reserve ...

Generally Clubs see active reserve membership as an honoured category- only available to those members who have carried out between 10 and even 15 years patrol duties.

The National survey however found the variations to range between three seasons of patrols to fifteen seasons.

The true purpose of the whole membership standardisation and definition programme, was actually two fold -with the second reason in many peoples mind being more important than the first.

By using common definitions of membership, it was at last possible to have a National policy on the subject of competitions and patrols.

This policy now adopted by the Council, states quite clearly the obligation for competitors at Surf Life Saving competitions - to be either active patrolling members or those persons who have achieved an honoured category such as life membership, active reserve, etc.

Only in a handful of cases was the situation being abused, but the new definitions and competition/patrol policy will now ensure that life savers at Carnivals are just that- life savers.

Therefore it appears the Long Service membership category was introduced by SLSA in 1980.

National 10 & 15 Year Patrol Service Awards

During the 1984/85 season the National Council instigated the National 10 & 15 Year Patrol Service; Awards as recognition of the outstanding service many surf lifesavers have given to the community as patrolling members.

Only members who have completed 10 or 15 years of full (100%) patrol duties are eligible for the awards.

Therefore a National 10 & 15 Year Patrol Service; Awards was introduced by SLSA in 1985.



At the 8th June 1986 Annual General Meeting the Constitution was amended to add a membership category for Long Service Membership.

Long Service Membership

Long Service Membership may be granted by the Club to members who have completed ten (10) active years active service or to members who have completed eight (8) years service plus four (4) years reserve active service.

Such members shall be exempted from all patrol obligations and may be granted other special privileges of membership as provided in the Club Constitution and By-Laws.

Such members shall complete the Annual Proficiency Test if they desire to compete in Association competitions. In exceptional circumstances it shall be competent for the Club to grant Long Service membership to an Reserve Active Member irrespective of the number of years served as an Reserve Active Member.

Minor changes were made during changes to the Constitution when the Club operational structure was updated in July 1997. That Long Service members have voting rights was added and Association was changed to SLSWA and SLSA.

At the 23rd July 2000 Annual General Meeting the Constitution was amended to allow for the Club Award:

Resolution 2: To add to the category of Long Service Membership so that in addition to the State membership, a member can earn a club award for 10 years service specifically to the Club.

That the following amendments be made in order to effect Resolution 2:

The deletion of clause 6.6.4 and replacement with the following:

"6.6.4 Long Service Members who have completed ten (10) active years active service at Swanbourne Nedlands SLSC or to members who have completed eight (8) years service plus four (4) years Active Reserve at Swanbourne Nedlands SLSC shall be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 3 of this Constitution.."

The deletion of clause 6.6.6 and their replacement with the following:

"6.6.6 The Life Membership Committee will monitor awards and make recommendations to the Management Committee on the presentation of this award."

At the 14th July 2002 Annual General Meeting the Constitution was amended to differentiate between the membership category and the Club award.

Resolution 2: To differentiate between the Long Service Award awarded by the Swanbourne Nedlands SLSC and the Long Service Membership category of the Surf Life Saving Association (for both the 10 year and 5 year service awards)

That the following amendments be made in order to affect Resolution 2:

The deletion of clauses 6.6.1, 6.6.4, 6.6.5, 6.6.6 and their replacement with the following:

"6.6.1 Long Service Membership must be given by the club to members who have completed ten (10) years Active Service or to members who have completed eight (8) years Active Service plus four (4) years Active Reserve service."

- 3.1 Long Service Award
- 3.1.1 Members who have given 10 years of service to the club will be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 2 of this Constitution.
- 3.1.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis.

BY-LAWS

3.1 Long Service Award

- 3.1.1 Members who have given 10 years of service to the club will be presented with a suitably inscribed distinguishing badge to the design illustrated in Appendix 2 of this Constitution.
- 3.1.2 The Management Committee will be the sole judge of what constitutes "service", and will make decisions on recipients on a case-by-case basis.
